Assembly and use of professional fireworks
Assembly and use of professional fireworks: The responsible certified pyrotechnician must enclose a scale drawing of the launch area with the application. The drawing should specify the launch site, fire extinguishing equipment, all safety distances to the spectators, flammable storage facilities, livestock, buildings, highly flammable roofs and flammable vegetation with due regard to the wind direction
Assembly and use of stage fireworks: The responsible certified pyrotechnician must enclose a scale drawing of the stage area with the application. This must include the position of the fireworks and the cordon around them, fire extinguishing equipment, safety distance to the spectators and to highly flammable materials and information on the ceiling height of the premises.

Guidelines

The form is used when applying for authorisation to use professional fireworks.

- 1-2 Name, address and telephone of the person who is the responsible certified pyrotechnician.
- 3 If there are several other certified pyrotechnicians, enter their names, addresses and certificate/personal ID numbers here. This only applies to certified pyrotechnicians who are on site when the fireworks are used.
- 4, 5, and 6 Enter the address of the place of use. Remember to enclose a scale drawing with the application.
- 7 State when the fireworks will be used (date and time).
- 10 and 12 Information on the firework items used and the launch area.
NB Alternative fireworks must also be specified or if changes are made before the event, the fire brigade must be informed of this no later than in connection with planning the event.
- 11 Remember the date and signature.

The application must be submitted no later than 14 days before the fireworks are to be used.
Send the form to the municipal council for the municipality in which the firework display is to be held.

Please note! The application can only be processed if all fields are completed correctly and the annexes enclosed contain the necessary information.

The authorisation can not be regarded as having been granted, if the municipal authorities has not replied within the set time.
